2. **Non-Residential Track:** Designed for individuals who prefer staying in their home countries, this track allows fellows to work on a practice-based project. Non-Residential Fellows actively participate online and in-person for fellowship modules, culminating in a Postgraduate Certificate in Social and Economic Equity upon successful completion.
